

## ADELAIDE VENUE MANAGEMENT (AVM) CONDITIONS OF ENTRY

The AVM Conditions of Entry apply to the following venues for which AVM manages and operates:

- Adelaide Convention Centre, North Terrace, Adelaide SA 5000, www.adelaidecc.com.au/
- Adelaide Entertainment Centre, Port Road, Hindmarsh SA 5007, www.theaec.net/
- Coopers Stadium, Holden Street, Hindmarsh SA 5007, www.coopersstadium.com.au/

In addition to the AVM Conditions of Entry, each of AVM's venues may have additional conditions of entry that apply for each venue or specific events – see venue specific websites for details. The AVM Conditions of Entry are to be read in conjunction with these.

Further, venue hirers, ticketing agents and governing bodies may have other specific conditions of entry, and these shall also apply to AVM's venues during applicable events. The AVM Conditions of Entry are to be read in conjunction with these.

Breach of any conditions of entry may result in bans as detailed in the AVM Conditions of Entry.

## **Conditions of Entry**

- AVM reserves the right to refuse entry to any person/s.
- Patrons strictly enter at their own risk.
- Patrons may be required to show valid identification on entry and at any other time.
- All persons 16 years or older entering the venues must be fully vaccinated against Covid-19 with a vaccine approved by the Australian Therapeutic Goods Administration and show valid proof of vaccination.
- Screening/Security checks may apply on entry and at any other time.
- AVM may inspect carry and clothing items for prohibited and/or illegal items see venue specific websites for details.
- Restrictions, including exclusion, may apply to the size and nature of any carry items permitted into specific venues and/or events see venue specific websites for details.
- AVM accepts no liability for damage, lost or stolen property.
- Minimum dress standards apply and AVM may refuse entry or remove from venue any person failing to meet required standards see venue specific websites for details.
- Surveillance equipment may be in use within venues and surrounding the venues, and patrons may be filmed/photographed to assist in law enforcement and protection of public interest, patron safety and AVM property.
- Minors under the age of 12 must be accompanied by a carer 16 years or older.
- Smoking, including E-cigarettes and similar devices, is not permitted within 15 metres of any venue entry point. Smoking is strictly limited to designated smoking areas, if any, within venues.
- Alcoholic beverages are not to be taken into or out of any venue.
- AVM may take photographs for publication and promotional purposes.
- No animals are permitted, with exception of guide dogs.
- No wearing of colours or insignia signifying association with outlaw motorcycle group is permitted.
- Strobe lighting may be utilised at AVM's venues.
- AVM's venues are places of mass gathering whereby the transmission of viral illnesses (e.g. COVID-19) and other diseases that may have serious impacts on personal health, including

death, is of elevated risk. Any person attending an AVM venue accepts that risk, and also accepts that risk on behalf of any accompanying minor/s.

- Patrons are required to adhere to the directions issued pursuant to the Emergency Management Act 2004 (SA) which includes any COVID Management Plan, COVID Safe Plan or other requirement of a direction issued under that Act
- AVM requires guests to comply with the wearing of masks as directed upon entry to venues and at any other time. Failure to comply may result in removal from venues and penalty.

## Failure to Comply - Penalties

Irrespective of lack of action or any penalties issued by relevant authorities and/or governing bodies, AVM may apply the following <u>minimum</u> penalties for breaches of the AVM Conditions of Entry:

- Ignition of Flare Life time ban
- Selling of drugs or illicit substances Life time ban
- Significant act of violence as determined by AVM Life time ban
- Interfering with Emergency Equipment Life time ban
- Entering a venue without being fully vaccinated against Covid-19 5 year ban
- In possession of Flare 5 year ban
- Entering restricted area during performance or event (e.g. field of play, stage, foyer, back of house, etc.) 5 year ban
- Moderate act of violence as determined by AVM 5 year ban
- Multiple evictions from AVM venue/s 5 year ban
- Deemed to be a security risk as determined by AVM 3 year ban
- Possession of drugs or illicit substances 3 year ban
- Minor act of violence as determined by AVM 3 year ban
- Use of serious threatening, racist, discriminatory or sexist language as determined by AVM 3 year ban
- Deliberate causing of damage to venue 3 year ban
- Bringing unauthorised alcoholic beverage/s into venue I year ban
- Refusing to wear a mask as directed I year ban
- Use of moderate threatening, racist, discriminatory or sexist language as determined by AVM I year ban
- Vomiting due to intoxication 6 month ban
- Smoking in non-smoking area 6 month ban
- Failure to follow reasonable direction 6 month ban
- Use of inappropriate language 6 month ban
- Possession of unauthorised banner/signage 6 month ban
- Bringing unauthorised food or non-alcoholic beverages into venue 3 month ban

AVM reserves the right to ban patron/s from one or more of its venues for breach of the AVM Conditions of Entry at a single venue, and to impose penalties for incidents and/or behaviour not specifically covered by the AVM Conditions of Entry. No refunds shall be paid.
